In line with the implementation of the E-Invoice system by the Inland Revenue Board of Malaysia (IRBM), we kindly request **all local Malaysian students** to provide their **personal Tax Identification Number (TIN)**. Please ensure that **only your personal TIN** information is submitted. **Do not provide your parent's or guardian's TIN information.**

Individual taxpayers can perform a TIN search by entering their identity card number through the MyTax Portal at <https://mytax.hasil.gov.my>

If you need to search for your TIN, ask a parent with access to the account to log in to the MyTax portal. Once logged in, click on "Search TIN" located at the top right of the page, and proceed with the search using your **(student) NRIC**.
